**1.** Agenda No.1 : As per Agenda No.1 members discussed and the panel of members was formed for restructuring the syllabus of M.Com Course – Commerce subjects. Dr.Rashmi Hasamnis and Dr.Jyoti Thakur proposed that **M.Com structure has to be revised** and implemented from the academic year 2020-21. A detailed discussion was held among members and proposed structure is attached along with the list of panel members for restructuring various papers. It was decided that each course will be 25 percent Internal Evaluation and 75 percent External Evaluation.

### Agenda No. 2: In any other matter, members discussed and resolved

- 1. Dr.Nitin Songirkar from SMRK Nashik represented that in M.Com course the admission is restricted due to **Internship and Research Project**. He proposed an alternative to have optional papers. However, this would lead to increase in work load of University Departments. We request the Academic Council to delibrate on this issue and help us with some solution.
- 2. A representation made by SMRK College, Nashik, stated the problem of shrinking admission in FYBCom / MCom-I course because of the present eligibility criteria, which does not permit Science, Home Science, Diploma and any other Vocational Courses students to take admission in FYBCom, as today a lot of options are available. All the members felt that eligibility criteria has to be revised and widened for UG and PG Courses in Commere.
- 3. **Revised Syllabus of BCOM(AFI) Sem I and II** to be implemented from 2020-21 submitted. Members approved the syllabus of Commerce papers. (Copy attached)
