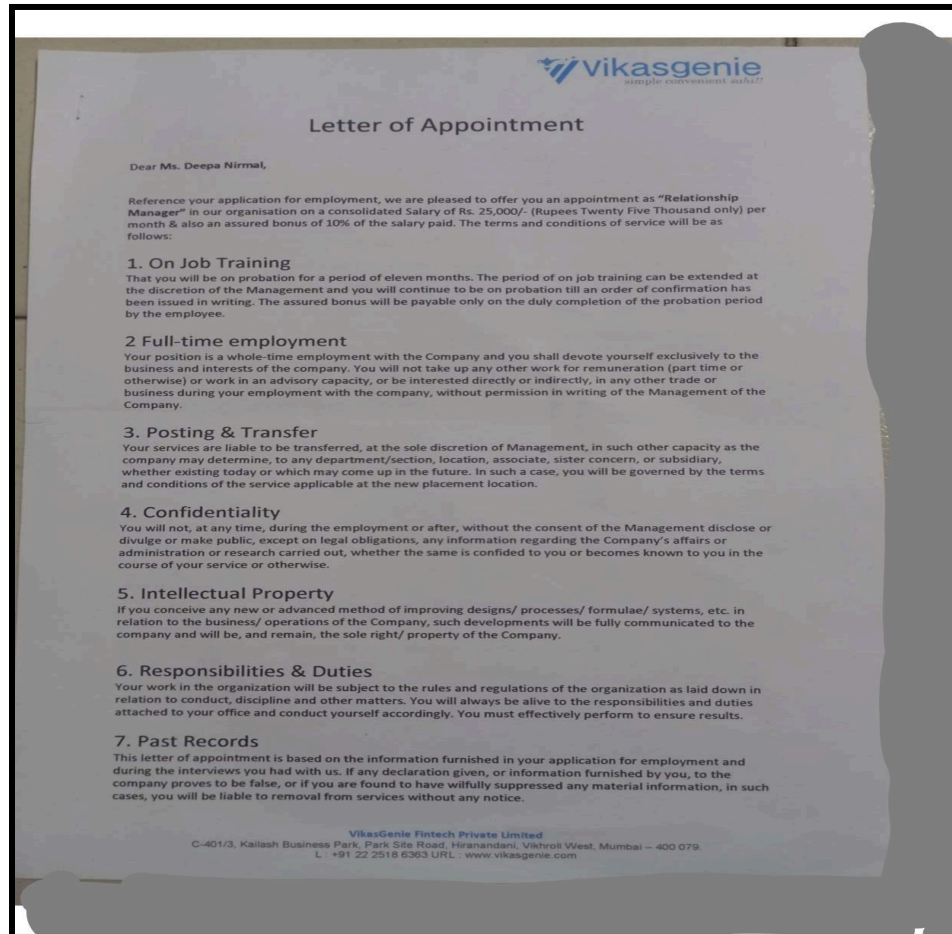

## 8. Termination of employment



- a) Salary structure – You will be paid a yearly salary of **Rs 1,80,000.00**. The details of your salary break up with components are mentioned in the enclosed Annexure.
- b) You're reporting and responsibilities will be advised to you by your Departmental Head or any person nominated by him/her.
- c) You will be on the probation period of six months

Your employment with us will be governed by the Terms & Conditions as detailed in Annexure – A.

**1. Personal Particulars:**

You will keep us informed of any change in your residential address, your family status or any other relevant particulars. You would also let us know the name and address of your legal heir/nominee.

**2. Nature of Work:**

You will work at high standard of initiative, creativeness, efficiency and economy in the organization. The nature of work and responsibilities will be assigned and explained to you by your senior from time to time.

**3. Working Hours:**

The regular working hours of the company are from 10 TO 7 PM Sunday (Weekly Off) including 30 minutes for lunch break.



**4. Assignment, Transfer:**

Though you have been engaged to a specific position, the company reserves the right of transfer/assignment to any of the company's branch offices in India, whether existing at the time of your appointment or to be set up in the future.

**5. Training:**

You will hold yourself in readiness for any training at any place whenever required. Such training would be imparted to you at the company's expense. Kindly note that refusal to participate in a training program without any extraneous circumstances would lead to automatic termination of your employment.

**6. Intellectual Property Right:**

If during the period of your employment with us you achieve any invention, process improvement, operational improvement, or other process/method likely to result in more efficient operation of any of the activities of the company, the company shall be entitled to use, utilize and exploit such improvement and you shall assign all rights thereof to the company for the purpose of seeking any patent rights or for any other purpose. The company shall have the sole ownership rights of all the intellectual property rights that you may create during the tenure of association with the company including but not limited to the creative concept that you may develop during your association with the company.

**7. Secrecy/Confidentiality:**

You will not during the course of your employment with the company or at any time there after divulge or disclose to any person whomsoever, make any use whatsoever for your own purpose or for any other purpose other than that of the company, of any information or knowledge obtained by you during your employment as to the business or affairs of the company including development, process reports and reporting system and you will during the course of your employment hereunder also use your best endeavour to prevent any other person from doing so.

**8. Revenue generation:**

You are required to generate the minimum profit which equals your one month salary in the first month of joining and from the later months onward the profit amount required to be generated is five times of your salary offered in order to receive each month's salary.

**9. Restrain:**

**i. Access to Information:**

Information is available on need to know basis for specific groups and the network file server of the company is segregated to allow individual sectors information access for projects and units. Access to this is authorized through access privileges approved by unit mentors or project mentors.



**ii. Restriction on Personal Use:**

Use of company resources for personal use is strictly restricted. This includes usage of computer resources, information, internet service, and working time of the company for any personal use.

**10. Leave:**

You will be entitled to leave as per law in force & rules of the company. Three day's advance intimation is required to be given for availing leave. In the event of a sick leave you will be required to furnish a doctor's certificate for the period of leave. The company follows strict time schedule and late comings are discouraged, unless otherwise notified by you in advance. Late marks will be accorded to you for every late entry with half day of absence counted for every three late marks.

You will be eligible for 1.5 days leaves in a month after the Letter of Confirmation is issued to you. Annually 18 leaves will be applicable to you. If the leaves are not utilized in a month then it will be carried forward in the next month. The accumulated leaves in a year will be encashed.

**11. Security:**

Security is an important aspect of our communication and office infrastructure. Communication security is maintained by controlling physical access to computer system, disabling all working stations, floppy disk drives and companywide awareness about the need for protection of intellectual property and sensitive customer information.

**12. Termination of Service:**

- i. The company can terminate this employment by giving the notice of seven days or with immediate effect.
- ii. Absence without permission from duty for a continuous period of 7 days would make you lose your lien on employment. In such case your employment shall automatically come to an end without any notice of termination or notice pay.
- iii. You will be governed by the laid down code of conduct of the company and if there is any breach of the same or nonconformance of contractual obligation or with the terms and conditions laid down in this agreement, your service can be terminated without any notice; notwithstanding any other terms and conditions stipulated herein the company reserves the right to invoke other legal remedies as it deems fit to protect its legitimate interest.
- iv. If the employee has to resign, then a formal mail of resignation must be sent to the reporting authority and HR and serve the notice period of minimum 15 days or as required at that point of time depending on the nature of work to be handed over.
- v. The experience letter will be issued only if the employee has tendered the formal resignation email, served the required notice period, completed the exit formalities and work duration of six months.

**13. Appointment in Good Faith:**

It must be specifically understood that this offer is made based on your proficiency on technical/professional skills you have declared to possess as per your application for employment and your ability to handle any assignment/job independently. In case at a later date any of your statements/particulars furnished are found to be false or misleading or your performance is not up to the mark or falls short of the minimum standard set by the company, the company shall have the right to terminate your services forthwith without giving any notice notwithstanding any other terms and conditions stipulated therein.
